INSURANCE APPLICATION CHECKLIST

These Items are required with all Classic Car insurance applications:

- Driver license**
Pollman's Insurance Agency Inc., hereafter referred to as "we" or "us," must be presented with a copy of each driver's license for every driver in the household, regardless of their intent to drive the vehicle.
- Registration**
A copy of the current vehicle registration must be provided to us. Do not send in a DMV renewal form; we must have copy of the actual registration.
- Copy of present auto policy**
We require a copy of the declaration's page that is issued with your insurance policy and outlines the coverage you have on each of the vehicles in your household. If you presently have a Classic Car policy, we must have a copy of it also. Insurance ID cards are not acceptable.
- Photographs**
Photographs are required for ALL vehicles including Pickup Trucks. The photos needed are of the front, rear, left and right sides, engine, and interior of the vehicle as well as a photograph of the garage that the vehicle is kept in. On trucks we additionally need a photo of the truck bed.
- Broker Agreement**
Please sign and date the enclosed Broker Agreement Form.
- Payment**
Make checks payable to Pollman's Insurance Agency. For the amount of \$ _____
- Modified - kit car - replica car**
We need a completed Modification Questionnaire.

NOTE: There is no coverage granted until the application is received and approved by Pollman's Insurance Agency. You will be notified upon approval of your insurance policy.
